The radio program of his Imus in the Morning was broadcast in several stations and digital platforms throughout the country until 2018. In 1968, he began the first radio work of him, in Kuty, in Palmdale, California. Three years after, he landed the morning transmission position on WNBC, in New York City. Imus was fired from WNBC in 1977, then he hired, in 1979, remaining in the station until he left the air in 1988, at which time his program moved to WFAN, which took charge of the previous frequency of WNBC of 660 kHz.
